



Data Protection and Privacy Policy

Statement of Privacy:

The Martinsville-Henry County Chamber of Commerce respects the privacy of its members and of those visiting our website. Any information that is submitted to the Martinsville-Henry County Chamber of Commerce is only used in the manner that you consented. We monitor our web site logs to track the flow of traffic and make improvements to its content.

Personally Identifiable Information:

Non-Identifiable Information:

Non-Identifiable Information includes, but is not limited to, information that we automatically collect on your actions on our web site. (ex. page views, click through counts, and traffic patterns). When a visitor arrives at our site, we can track the IP address which can give us a geographic location of the connection.

Non-Identifiable Information helps us to determine how the Martinsville.com web site is being used, helps us identify heavily visited areas of our site and helps determine the value of our promotional activities regarding the site.
